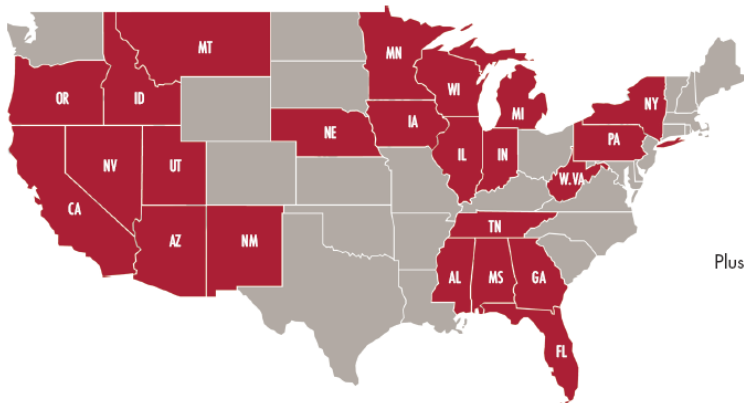
Frontier offers ILEC (incumbent local exchange carrier) services to 2.3 million access lines plus 559,000 High-Speed Internet subscribers in 24 states. Frontier is one of the largest rural local exchange carriers in the country. Frontier offers customers a "Peace of Mind" experience with competitive packages of services and products that allow them to bundle their basic telephone line with television (through DISH Network), and enhanced products and data services. Calling features include call forwarding, conference calling, caller ID, voice mail and call waiting. Data services include wireless broadband data, Internet access via dial-up or DSL, frame relay, Ethernet and asynchronous transfer mode (ATM) switching in portions of our system. Our Virtual Private Networks (VPN) allow business customers to connect remote offices and/or mobile workers to their networks economically and efficiently.
